IAEA CERTIFICATE OF COMPETENT AUTHORITY SPECIAL FORM RADIOACTIVE MATERIALS

This certifies that the sources described have been demonstrated to meet the regulatory requirements for special form radioactive material as prescribed in the regulations of the International Atomic Energy Agency¹ and the United States of America² for the transport of radioactive material.

- 1. <u>Source Identification</u> QSA Global, Inc. Models X10 and X10/2
 (Manufactured on or after June 22, 1977).
- 2. <u>Source Description</u> Cylindrical single encapsulations made of stainless steel and tungsten inert gas or laser seal welded. Approximate outer dimensions are 8.1 mm (0.32 in.) in diameter and 5.4 mm (0.21 in.) in length. Minimum wall thickness is 0.2 mm (0.004 in.). Construction shall be in accordance with attached AEA Technology QSA, Inc. Drawing No. RBA11049, Rev. A.
- 3. <u>Radioactive Contents</u> No more than 1.85 GBq (50.0 mCi) of either Americium-241 or Curium-244. The Am-241 and Cm-244 are in the form of an oxide incorporated into a ceramic enamel.
- 4. <u>Management System Activities</u> Records of Management System activities required by Paragraph 306 of the IAEA regulations shall be maintained and made available to the authorized officials for at least three years after the last shipment authorized by this certificate. Consignors in the United States exporting shipments under this certificate shall satisfy the requirements of Subpart H of 10 CFR 71.
- 5. <u>Expiration Date</u> This certificate expires on March 31, 2025. Previous editions which have not reached their expiration date may continue to be used.


