IAEA CERTIFICATE OF COMPETENT AUTHORITY SPECIAL FORM RADIOACTIVE MATERIALS

This certifies that the source described has been demonstrated to meet the regulatory requirements for special form radioactive material as prescribed in the regulations of the International Atomic Energy Agency¹ and the United States of America² for the transport of radioactive material.

- 1. Source Identification Gammatron Model GT-GHP.
- 2. <u>Source Description</u> Cylindrical welded double encapsulation made of K-Monel 500 (USN N05500) or Armco 17-4 (USN S17400). Approximate outer dimensions are 6.35 mm (0.25 in.) in diameter and 12.7 mm (0.5 in.) to 31.75 mm (1.25 in.) in length. Construction shall be in accordance with attached Gammatron Drawing No. A-3000.
- 3. <u>Radioactive Contents</u> No more than either 0.037 TBq (1.0 Ci) of Cesium-137 as glass microspheres, 0.037 TBq (1.0 Ci) of Cobalt-60 as metallic pellets or wire, 93 kBq (2.5 uCi) of Radium-226 as metallic foil, or 0.0037 TBq (0.1 Ci) of Californium-252 as metallic pellets or wire.
- 4. <u>Management System Activities</u> Records of Management System activities required by Paragraph 306 of the IAEA regulations shall be maintained and made available to the authorized officials for at least three years after the last shipment authorized by this certificate. Consignors in the United States exporting shipments under this certificate shall satisfy the requirements of Subpart H of 10 CFR 71.
- 5. <u>Expiration Date</u> This certificate expires on August 29, 2025. Previous editions which have not reached their expiration date may continue to be used.


